





Background & authority

- Authorized by President Truman's 1946 Hill-Burton Act (first step toward Medicare); privatized in 1984
- FGI sets standards for health care facilities in 44 states and serves as a reference standard for 6 states
- ▼ The reference standard for LEED HC, IgCC + 87 countries
- FGI has been a 501(c)3 nonprofit since 1998
- Health care is one of America's largest, richest, most technologically advanced, research-intensive, and fastest growing industries – 20% of U.S. GDP

FGI's Methodology

- FGI's four-year update process yields quadrennial "minimum requirements" enforced by state/regional authorities having jurisdiction (AHJs)
- CIP (continuous improvement process) is a widely respected set of management methodologies (Deming) that encourage continual improvement, adaptation, and change

What's a "minimum requirement"?

- Primum non nocere the Hippocratic injunction
- First, do no harm
- NOT equivalent to "best practices" or "consensus standards" or "recommendations"
- REALITY: must be accepted by state legislatures and AHJs (state regulatory authorities)
- Authoritative, conflict of interest (COI)-free evidence is essential

What's an "AHJ"?

- "Authority Having Jurisdiction (AHJ) an organization, office, or individual responsible for enforcing the minimum requirements of codes, standards, and permits for approving equipment, materials, and installations or a procedure within its jurisdiction"
- FGI includes <u>30</u> AHJs on its committees to ensure regulatory points of view are represented

What's "valid evidence"

- ✓ Valid evidence is essential for FGI to assess proposals. "Valid evidence" means:
 - Independent, institutionally based, funded, thirdparty, peer-reviewed research conducted by relevant multidisciplinary teams (e.g., doctors + engineers)
 - Demonstrably free of conflicts of interest
 - Must demonstrate impact on health AND economic outcomes
 - Generally includes cost-benefit analysis

Three examples...

- For the past 16 years, FGI's acoustics committee has organized over a dozen research projects. Here are three examples (2nd and 3rd were organized and seed-funded by the acoustics committee & FGI):
 - Johns Hopkins Meta-analysis (2006, Busch-Vishniac & West et al.) an important benchmark!
 - Harvard Sleep Study (2011, Buxton, Ellenbogen, Carballeira, Solet et al.)
 - Rothschild-FGI Acoustics in Residential Care (2016, Kachur, et al. [unpublished])

FGI's acoustics committee

- Officially known at FGI as the APRC (Acoustics Proposal Review Committee) web address is "Quiet Healthcare"
- **Formed in 2005** − 16 years of continuous, independent operation with changing membership
- Developed acoustic content for five editions of the FGI Guidelines + the Springer book "Sound & Vibration 2.0" (2010)
- Composed of 15 leaders in acoustics and related disciplines
- Core group represents ASA's AA, NS, and PP divisions

Acoustics and FGI

Submit Proposals to FGI

- Continuous improvement to the FGI *Guidelines* occurs through proposals submitted by the public and FGI committees during the revision cycle.
 - 1. Public proposal period (spring 2023)
 - Support with research
 - Authoring tips at the FGI website
 - 2. Public comment period
 - Opportunity to comment on changes shown in the draft document
- Proposals and comments on acoustics are reviewed by the Acoustics Proposal Review Committee.
 - Recommendations made to the Health Guidelines Revision Committee (HGRC), who make the final decision.

Considerations for proposals

For example, to assess proposals regarding acoustic comfort or other health care topics, FGI seeks answers to these questions:


- Are there extant standards?
 (e.g., ANSI, ISO, ASTM, ASHRAE)
- Do new standards need to be developed?
- 3. Do the standards address methods for measuring occupant health, safety and welfare?

Considerations for proposals

- 4. Has independent research measured occupant health, safety and welfare in clinical settings?
- 5. Does research include measures of physiological and psychological responses from patients and/or staff (e.g., stress hormones, blood pressure, etc.)?
- 6. Are there plans for independent, COI-free research in health care facilities—if so, on patients, health care professionals, or both?
- 7. Does it support the health care "Quadruple Aim"?

What is the "Quadruple Aim"?

Proposals should mind the health care Quadruple Aim.



APRC membership

- Membership is by invitation or application
 - Credentials may be sent to FGI or to any acoustics committee member
- The committee is balanced according to:
 - Geography
 - Gender
 - Age
 - Profession (acoustics, medicine, public health, architecture, design, engineering)
 - Credentials

2022 edition activity highlights

- Highlights of activities in support of 2022 documents
 - **Resulted in 14 major changes to the** *Guidelines.*
 - Reviewed approximately 100 public proposals, plus comments from code officials and the HGRC Steering Committee.
 - Developed proposals to improve acoustics sections based on new evidence and research.
 - New language in FGI's "Project Planning" section recommending acoustics approval (safety risk assessment appendix text)
 - Drafted patient and health care professional telehealth checklists for publication in FGI's Beyond Fundamentals library (pending)

2022 edition policy highlights

- Policy issues raised by federal laws and changes by agencies and/or medical profession:
 - CDC-NHANES report ("disabilities" to include hearing loss per ADA)
 - American Public Health Association policy approved: redefines "noise" as "unwanted and/or harmful sound"
 - 2018 SCOTUS decision Affordable Care Act recognized as "settled law," enabling HCAHPS enforcement
 - Other policy activities affiliated with the National Academy of Medicine, President's Council on Science & Technology, American Academy of Pediatrics

APRC mission & goals 1-4

- 1. **Promote, accelerate, and support** patient recovery through acoustic conditions that reduce stress and anxiety while encouraging sleep and growth.
- Prevent medical errors caused by miscommunication, stress and fatigue among patients, medical professionals, and caregivers and families.
- Protect speech privacy and security.
- 4. Track and interpret scientific and regulatory environments by focusing on relevant medical, scientific, legislative, and federal agency guidance.

APRC mission & goals 5-7

- 5. **Develop** and continuously improve regulatory criteria to ensure they are realistic, understandable, and enforceable through rigorous commitment to FGI's continuous improvement process (CIP)
- 6. **Listen, learn, and teach** by being active in the work of allied professional societies in disciplines appropriate to the committee's work.
- 7. Recruit, retain, and refresh a balanced team of top professionals from medicine, public health, and acoustic science who are committed to teamwork and collaboration.

Let's talk!

- FGI's acoustics committee is **already organizing** for the next *Guidelines* edition in 2026.
- We seek to broaden representation to include ASA divisions Psychological & Physiological Acoustics, Speech Communications, Architectural Acoustics, and Noise.
- We plan to develop a research roadmap.
- We plan to simplify **speech privacy** and do further work on **signal-to-noise ratio** and **disability rights** and **operating room** noise.
